1. Entrants must hold membership as follows:
 - a. Current USBC card (purchase associate membership or pay a participation fee of \$5.00) & current NYS USBC membership.
 - b. Current NYSW 600 Bowling Club card (membership may be obtained at time of entry).
2. **Entry fee shall be \$25** (prize fee \$12.50 and expense/bowling fee \$12.50). **NO REFUND OF ENTRY FEE. Return check fee \$20.00**
3. Entrants shall bowl **THREE** games on same pair and may participate only once.
4. The tournament will be conducted in five divisions, according to average:

5. Average requirements as follows:
 - a. Highest USBC certified league average as of the end of the previous season, minimum of 21 games. Summer certified league average may be used provided no winter average is available and it meets the 21 games minimum requirement.
 - b. Bowlers who do not have a previous season or summer average shall use their highest certified league average as of **APRIL 17, 2022** with a minimum of 21 games or bowl in Open Division.
 - c. Rule 319a-2 & 319d (regarding current season average being 10 pins or more, higher than previous season's average) **WILL NOT APPLY**
 - d. Rule 319d (regarding reporting of prize winnings) **WILL NOT APPLY.**
 - e. Tournament Manager will verify all averages through BOWL.com and will change any incorrect average.
6. In the case of a tie for first place, in any or all divisions, co-champions will be declared and duplicate awards will be presented. Cash prizes for all ties will be equally divided. Prize Ratio 1-5. Prize money returned 100% in each division.
7. Substitutes will be permitted to bowl before the start of the first game provided they meet the requirements of the tournament rules.
8. Any rule not covered will be decided by the Tournament Chairman.
9. **Entrants who wish to bowl together must send their entries together. NO DATE CONFIRMATION WILL BE SENT, YOU WILL BE NOTIFIED IF YOUR FIRST CHOICE IS NOT AVAILABLE. Bowler must report one hour prior to scheduled squad time.**
10. All entries postmarked the first Post Office business day following the entry closing date shall be accepted. **ENTRIES CLOSE 5/2/2022**
11. ATTIRE: Suitable attire required. **(NO SHORT SHORTS OR SHORT SKIRTS)**
